4. The boiler installation must be completed by a Gas Safe Registered Installer who is authorised and regulated by the Financial Conduct Authority ("Installer"). 5. 0% APR representative on the cost of installation is available on boiler installations up to the value of £2200 with no deposit required. Any additional cost above £2200 must be paid by the customer. Representative example: Total credit £2200 (0% fixed), 36 monthly payments of £61.11. Total amount payable £2200. Other options may be available.
6. It is the Installer's responsibility to claim either (i) the 0% APR Representative Offer, or (ii) the £300 Cashback Offer from firmus energy within 90 days of the meter fit (Authorisation no. required from firmus energy). If the Installer fails to do so, the offer shall not apply. If the Gas Safe Registered Installer is not registered with firmus energy the customer must claim the £300 Cashback.

To receive a grant you must be a homeowner with a 15 year old oil boiler or older, live within 30 metres of the firmus energy natural gas network, and have a total household income of less than £40,000. Grant is part funded by the NI Executive and administered by the Housing Executive.
